

FOR THE AUTHORS' INFORMATION

Rules for the preparation of manuscripts

1. The article must be submitted in electronic form. The volume of original articles, including tables, figures, literature and summaries, should not exceed 5-8 pages, reviews and lectures - 8-10 pages.
2. The article must be printed with 1 spacing on a computer, font 12.
3. Each article must contain:
 - a) UDC code (if available);
 - b) full title of the article and abstract in Russian, Uzbek and English
 - c) full name authors, academic degree, scientific title, name of the institution where the work was done in Russian, Uzbek and English after each topic;
 - d) full name supervisor (if any);
 - e) postal e-mail address and phone numbers of the author, with whom editorial work should be carried out.
 - f) words that, in the opinion of the author, should be highlighted, are underlined by him in the text. Special alphabetic fonts and symbols (for example, letters of the Greek alphabet), as well as links to figures and tables, are placed on the left margin at their first mention.
 - g) units of measurement must be expressed in units of the International System (SI), if necessary, in brackets after the SI unit, the dimension in other systems can be indicated.
4. The article should be carefully verified and structured with the following headings:
 - relevance,
 - purpose of the study,
 - materials and methods,
 - results and discussion,
 - conclusions.

The presentation of the article should be clear, without lengthy historical introductions. Where in studies without statistical processing of the obtained material it is difficult to assess the reliability of conclusions and conclusions, statistical processing of digital data is mandatory.
5. Illustrations are presented inside the text; its number is indicated under the figure. Graphs and diagrams should not be overloaded with text labels. Microphotographs, photos, drawings must be black and white.
6. Tables must be printed in the text, have a title, be compact, visual, column headings must exactly match their content. All numbers must match the numbers in the text and be processed statistically.

7. The medicinal substances used and the methods of their administration must be approved by the Pharmacological Committee of the Ministry of Health of the Republic of Uzbekistan and allowed for clinical use. Materials on new devices, devices and instruments used in medical and social examination and rehabilitation must have a permit for new medical equipment of the Ministry of Health of the Republic of Uzbekistan.
8. Abbreviations (other than generally accepted ones) are not allowed. Symbols at the first mention are given in full.
9. The list of cited literature should be attached to the article, which should be formatted as follows: Citation of the list of used main literature should be at least 0.25 printed sheet. Sources are given in alphabetical order with the names of the authors and initials, first domestic, then foreign. The titles of books, journal articles, place of publication, publisher, year of publication, volumes and issue numbers, pages "from" and "to" are indicated in full. The works of domestic authors published in foreign languages are placed among the works of foreign authors in the general alphabetical order, and the works of foreign authors published in Russian are placed among the works of domestic authors in the general alphabetical order. All sources must be numbered, and their numbering must strictly correspond to the numbering in the text of the article. If several works of one author are cited (including those in co-authorship), they are arranged in chronological order. When referring to abstracts of dissertations, their title should be indicated. It is not allowed to refer to unpublished works. The author is responsible for the accuracy of the bibliography.
10. Submission to the editorial office of articles published in other publications or sent for publication to other editions is not allowed.
11. If the above rules are not observed, the articles are returned to the authors without consideration.
